As Chair of the Environmental Subcommittee of the Borrego Revitalization Initiative it has come to my attention there are three issues requiring the immediate collective attention of the County, the <u>Borrego Springs Subbasin Watermaster</u> (Watermaster), and the <u>Borrego Water District</u> (BWD). These issues are critical to the mission of the Borrego Revitalization Initiative in that these issues are potential public health nuisances and/or anathema to economic development if not adequately addressed in a timely fashion. These issues are briefly delineated below:

1) Air Quality in the Borrego Valley Basin. For the past five years, the Borrego Valley Endowment Fund (BVEF) and BWD, with no financial help from the San Diego County Air Pollution Control District (District), has funded five air quality monitoring stations in the Borrego Valley. These monitoring stations are operated by the University of California, Irvine (UCI), whose experts have conducted basic research on Borrego Valley ambient air quality. This data is extremely important for developing useful Stipulated Judgment (Judgment) irrigated farmland fallowing standards under the Sustainable Groundwater Management Act (SGMA) so as to not produce *undesirable results*. Presently, the fallowing standards in the Judgment are oriented toward dust containment for the short term (around 6-years). However, it appears there has been little thought on the part of the Watermaster or County regarding long term management of fallowed farmland and the enforcement of appropriate standards based on the location in the Valley of the fallowing. Given the potential scale of the fallowing effort under the Judgment and given the results of UCI's research indicating Borrego's ambient air quality has often exceeded the Environmental Protection Agency's (USEPA) public health standards, it is imperative the County and the Watermaster address potential long-term fallowing issues sooner rather than later to avoid or forestall excessive economic dislocations. My understanding is that it is much more expensive to address the health impacts from degraded air quality after the fact than to have a plan to avoid the problem in the first place.

- 2) Improperly Abandoned County-Permitted Irrigation Wells in the Borrego Springs Subbasin. An improperly abandoned well offers a direct route to the Subbasin's water table for toxins and pollutants. A consultant to BWD estimates there may be as many as 50 improperly abandoned wells in the Subbasin currently. It seems almost a given that the Watermaster cannot fulfill its role under the Judgment to adequately manage the future water quality of the Subbasin without a solution to the problem of identifying and enforcing the proper abandonment of wells in the Subbasin. Given the gaps in knowledge and the lack of timely enforcement actions by the County to address known abandoned wells, some have estimated it may take 20-30-years to complete this effort. This is unacceptable. BWD already has data on the cost to its ratepayers in the event basin-wide water quality degradation precipitated the necessity of advanced water treatment. Current estimates of capital and O&M costs to meet state and federal Minimum Contaminant Levels (MCLs) during the useful economic life of an advanced water treatment facility exceed \$40 million. Such cost would likely be too much for a Severely Disadvantaged Community (SDAC) such as Borrego Springs to address this foreseeable problem after the fact, when "before the fact" planning to address this issue in a timely fashion would be many tens of millions of dollars less expensive to BWD ratepayers.
- 3) San Diego County Water Authority (CWA) Regional Conveyance System (RCS) Route 3A through Borrego Springs. Bringing imported water with a pipeline to Borrego, at no cost to Borrego for the construction of the pipeline, may appear at first blush a boon to economic development. But on a closer analysis, based on CWA's Phase A studies to date, the economic cost of this delivered Colorado River water may be as much as \$3,000—\$6,000 per acre-foot (AF) [current delivered cost of Subbasin groundwater today runs approximately \$300—\$1900/AF] and require many millions of dollars in local infrastructure to use this water of vastly different water quality than existing Subbasin groundwater. Also mixing Colorado River water with Borrego Subbasin groundwater may present significant and costly water quality issues that exceed the ability of Borrego Springs to address on its own. This emerging issue should be of great interest to the County, the Watermaster, and BWD given its potential to subvert the objectives of SGMA responsibilities of the Watermaster under the Judgment, its impact on land-use plans of the County PDS, and its impact on affordability to BWD's customers. Unlike the two previous issues, advanced planning at this time is not necessary until CWA completes its Phase B economic analyses, which will then require independent analysis to verify the

economics should route 3A through the Borrego-Anza-Borrego Desert State Park and the community of Borrego Springs still be an option.

Call To Action - A 60-Day Time to Develop a Plan

I respectfully request our Supervisor, Jim Desmond, immediately convene a committee of appropriate County department representatives who would meet with designated representatives of the Watermaster and BWD. The task of this committee would be to develop a plan of action with deliverables in no more than 60-days to address: (a) <u>Air Quality in the Borrego Valley Basin</u>; and (b) <u>Improperly Abandoned</u>, <u>County-Permitted Irrigation Wells in the Borrego Springs Subbasin</u>.

In view of the entry of final judgment in the Borrego Springs Groundwater Adjudication lawsuit (Borrego Water District v. All Persons Who Claim a Right to Extract Groundwater in the Borrego Valley Groundwater Subbasin No. 7.024-01, et al., Orange County Superior Court case no. 37-2020-00005776) and the Court's appointment of a Watermaster to implement the judgment and accompanying groundwater management plan, Borrego Water District hereby withdraws as the groundwater sustainability agency (GSA) for the Subbasin effective as of the date this letter is uploaded to the Department of Water Resources (DWR) GSA portal. As discussed with DWR representatives, upon completion of an updated Alternative Elements Guide, the final judgment and associated documents will very shortly be submitted to the DWR SGMA Alternatives portal.

Subject: Water Rate Study Amendment Request

Dear Mr. Poole:

As you know we have encountered many unknowns during this contract which has taken more time than anticipated to incorporate into the water and sewer rate study. This amendment request seeks additional funding to recover unanticipated and out of scope work effort which has used our budget (as described below) and to cover costs to complete the study. The contract is a not-to-exceed time and materials contract based on our estimated effort.

Cost overruns are grouped into two categories, out of scope tasks and significant extra effort.

Out of Scope Public Meetings: In our 2020 proposal we estimated only one public meeting to complete the study. With our attendance at a future community meeting and a July 2021 Public Hearing Raftelis will have attended five additional public meetings¹ resulting in significant hours of planning with staff, development of meeting materials, meeting preparation, and actual meeting time.

Extra Effort: At the time of our proposal Raftelis was unaware of the involvement of the District's financial consulting firm Fieldman Rolapp and Associates (FRA). Raftelis staff participated in several working sessions between the FRA team, the Raftelis project team, and District staff to align the Raftelis and FRA model inputs and assumptions, and to reconcile model outputs. This included one-on-one time with FRA as well as follow up calls based on changes to District budgeted values and model iterations. Additionally, the water and wastewater models required several updates through the fall and winter of 2020/21 based on new information, updated operating budgets, updated FY 2021 rate implementation, and updated capital planning and financing assumptions.

Our budget overage at project completion is estimated to be approximately \$18,000. This considers the overage to date, the outstanding public meetings, as well as the outstanding task to update the District's

RECOMMENDED ACTION:

2. TAC UPDATE FROM TREY DRISCOLL, BWD REPRESENTATIVE

As per the request of the TAC and West Yost we provided fee to directly support West Yost with the update of the sustainable yield using the existing Borrego Valley Hydrologic Model.

In addition, I have been pushing the TAC to commence preparation of the water quality monitoring plan in WY 2022 as this is an important issue to BWD and Basin stakeholders. We are getting some push back from one TAC member so may need to bring up to the Wastermaster. I emphasized that based on work BWD is completing in the South Management Area (SMA) for Rams Hill WWTF and lack of major potable production in the SMA it may be advisable to refocus efforts to the North and Central Management Areas where data gaps exist.
